Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

Non-affiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

* Non-affiliates we may share with may include other developers, financial institutions and services companies, associations and exchanges, and other companies

Joint marketing

A formal agreement between nonaffiliated financial companies that

together market financial products or services to you.

* Our joint marketing partners may include our developers, financial institutions, financial services companies, and other companies

Other important information

VT: Accounts with a Vermont mailing addresses are automatically treated as if they have limited the sharing as described above. For joint marketing we will only disclose your name, contact information and information about your transactions.

CA: Accounts with a California mailing address are automatically treated as if they have limited the sharing with non-affiliates as described above. You may receive a separate notice regarding your rights and additional choices.
